She acknowledged the stress that everyone has been feeling, but emphasized that the council has worked as a team and remains committed. #### **Finance Committee**

The finance committee works to oversee the financial aspects of the church. Members of the committee are Allen Lewis, Kevin Lee, Carolyn Scheibe, Rhonda Webber and Deanna Nielsen. The committee meets as needed throughout the year. Two cash handling policies were written and adopted.

Our long-time financial secretary, Carolyn Scheibe resigned early in 2022. Carolyn had served in this position for over 20 years. We thank her for her dedication, technical skills, and willingness to teach and guide her replacement. Rhonda Webber accepted the financial secretary position and has quickly mastered the ICON database. Through August, offerings were counted and deposited weekly by a team of two people. Starting in September we returned to having two people count the offering and make a deposit after each worship service. The financial secretary enters all the contributions including online giving into our financial database, thus providing separation of duties and ensuring confidentiality.

Disbursement vouchers are submitted and approved according to the budget. The checks are written by our office manager, Beth Ann Anderson, and presented, along with the supporting paperwork to the treasurer for approval and check signing. This ensures complete separation of monies received and disbursed, with at least 2 people checking and involved in each step of the process.

Payroll is processed by Fahrenkrog Accounting. Church employees submit data to Pastor Carrie. She reviews the payroll before submitting it to the accountant for processing. The payroll checks are issued via electronic deposit.

Josh Rasmussen, Neal Becker and Matt Briehl reviewed the financial records in early April. Corrective actions have been implemented to address the audit recommendations.

Throughout most of 2022, the general fund expenses were more than the income. We started the year with large offerings in January that kept us funded until March when we needed to use reserve funds. At the end of September, we were over \$25,000 in the reserve funds but finished the year just \$1895 into the reserve funds. Offering in the last quarter for the general fund and the roof replacement were impressive! The chart shows the monthly balance (income minus the expenses).



The finance committee reviewed the 2023 budget requests from the council members, the synod's recommendation of 5.67% salary increases for the pastors, and the personnel committee's recommendation of 2% salary increases for all non-rostered employees. The final decision for the 2023 budget was determined by the council.

Finally, a big thank you to all who contributed to the re-roofing fund. Within the first 2 weeks of hearing of the need, half the money was raised. The total cost for the roof repair with the 20-year warranty was \$50,605. At the end of 2022, a total of \$48,640 had been contributed. Truly above expectations!

## **Audit Report 2021**

Audit Team: Neal Becker, Matt Briehl, and Joshua Rasmussen (Chair)

Audit Scope: January 1, 2021 – December 31, 2021

**Overview:** The audit team reviewed the control environment at the Faith Lutheran Church and found no major deficiencies. The audit was conducted based on the Faith Evangelical Lutheran Church Audit Guide as well as the Faith Evangelical Lutheran Church Audit Committee Charter. The audit review period was for Fiscal 2021 and was conducted between March 28th and April 11th, 2021.

#### **Observations & Recommendations**

<u>Banking & Investments</u> - Observation The year end fund balance sheet did not match the year end bank statement. As is the case with most checking accounts there were several items that had not yet cleared the bank account as of December 31. There were previously written checks and other items that had not cleared the bank account. Some of those items went as far back as 2015. There was a balance of \$73,238.09 to be accurate after adjustments were made for outstanding items

**Recommendation** Conduct a review of the outstanding items as of December 31, 2021, to determine whether they should be added back into the checking account or be replaced with a current check (some of these items are considered stale dated). Also, consider adding this as an annual review to ensure all necessary items have cleared in a timely manner.

#### Banking Reconciliations -Observation No deficiencies observed

<u>Petty Cash</u> - **Observation** Petty cash is rarely utilized and most transaction are via credit card transactions.

**Recommendation** If petty cash is necessary, adhere to the current standard to always keep the balance at \$20 through a combination of cash and receipts. If petty cash is no longer necessary, consider eliminating the use of petty cash and only using credit card transactions to have a better control going forward.

#### Income Benevolence - Observation No deficiencies observed

<u>Income Offering</u> - Observation For the weekend of June 24, there was no bank deposit receipt. There was a comment noting the missing receipt in the file. Another exception was found where the bank deposit receipt amount was \$5 less than the deposit slip total. The date of this deposit was October 12.

**Recommendation** Continue to strive for accuracy when counting the weekly offerings and completing the deposit slips. Retain all deposit documents.

<u>Disbursements</u> - Observation In the July miscellaneous folder, there was a payment to Lutheran Lakeside, check #18905 dated July 16 in the amount of \$2020.00. The description on the expense voucher said Adult Mission Trip Supplies and the account charged was #5310-adult mission. There was not any supporting documentation attached. The auditor found through discussions that this money was paid to Lutheran Lakeside for the purchase of repair materials and supplies for repair work completed by adult campers.

**Recommendation** Invoices are routinely paid in a timely manner. All check stubs note the account and account number being charged. When no source document is available, a written explanation in the file with the check stub will help alleviate questions in the future.

<u>Credit Card Transactions</u> - **Observation** While most credit card transactions had an auditable trail, there were a few small purchases where a credit card receipt was not provided. Most of these included a comment in the file noting that the receipt was not attached.

**Recommendation** Invoices or receipts should be retained and available to verify all credit card purchases. While the reimbursement/expense voucher has the account name to be charged, it might be beneficial for account accuracy to include the account number here as well. This would be similar to the information contained on the check stub for non-credit card disbursements.

<u>Payroll</u> - **Observation** There was 1 missing mileage log in the documentation from the period October 31, 2021. Additionally, some mileage logs contained the total miles but did not contain detailed information.

**Recommendation** Ensure supporting documents are attached to the payroll information. Also, include supporting documentation to support the total mileage log. If there is a recurring or monthly allowance, add a note on the mileage log to state how the total number was derived. Endowment Funds Observation No deficiencies observed

#### **ENDOWMENT COMMITTEE 2022 REPORT**

The endowment fund is estimated to finish 2022 with a balance of \$95,200.00. Included in that total was a generous, anonymous donation in the amount of \$20,000 this year. This fund was started in 1999 and accumulated funds until it reached \$50,000 in 2018. Since then, the interest has been expended following the committee's guidelines:

Minimum of 20 percent for outreach into the community and synod, including but not limited to grants to ELCA seminaries, colleges or students attending such schools, social service agencies, institutions and agencies and agencies to which this congregation relates, and to special programs designed for those persons in our parish area who are in spiritual and/or economic need.

Minimum of 20 percent for missions of Evangelical Lutheran Church in America in this continent and worldwide, including, but not limited to, grants to the Evangelical Lutheran Church in America for new congregational development in North America, professional leadership, educational ministries, global mission, ecumenism, evangelism, social ministries and capital financing.

Minimum of 20 percent for capital improvements, debt reduction or a building program of Faith Evangelical Lutheran Church.

Up to 40 percent for any or all of the above designated areas in any proportion as determined by the committee are consistent with the fund purpose of enhancing the mission outreach of Faith Evangelical Lutheran Church.

The amount of funds that were distributed at the beginning of 2022 was \$950.00 with funds going to the following:

\$237.50 (25%) to Faith Lutheran's Capital Unbudgeted Repairs/Maintenance fund.

\$237.50 (25%) to Lutheran Lakeside

\$237.50 (25%) to SEIA Synod General Fund

\$237.50 (25%) to ELCA Disaster Fund

\$950.00 Total disbursement

The interest amount from 2022 available for 2023 distribution is estimated at \$1,690.00. As the principal of this fund grows, obviously more income would be available for the above uses. If you have any questions on this fund, please contact Pastor Carrie or Ken Oetzmann. Ken Oetzmann, as financial secretary, has updated our CD's to take advantage of the rising CD interest rates.

## North Scott Community Feed Our Children Ministry 2022 Annual Report

Feed Our Children Ministry was organized by Faith Lutheran Church in June 2017 to provide a free lunch opportunity to our children in the North Scott community during the summer break. During a typical summer, almost 25% of children in our neighborhoods are underserved through the loss of the weekday free and reduced lunch program. Over the summers of 2017-2019 and 2022 we served more than **11,947** lunches in our community through our twice a week ministry.

We were excited to resume this program in the summer of 2022. Under the daily leadership of Katie and Sammie Garner, with support from members of the congregation and community, we were able to serve 3,197 meals during the 2022 summer break! These meals consisted of a lunch and additional items for snack or breakfast. Supply chain issues continued to be an obstacle, especially for the amount of bread we needed each week. God provided when a local bread truck driver stopped at a distribution site one day to ask if we could use bread! This need had <u>not</u> been advertised, and had only been discussed within our leadership. Thank you to Joan and Dennis Hennigan for following up on this lead and obtaining bread each week for the program. Children not only enjoyed the lunches, but also had bagels, muffins and other items supplied by this connection.

As we look forward to 2023, we ask for your continued prayers for the children and families in need, as well as the many people working behind the scenes to grow, harvest, transport, package, purchase, organize, prepare and serve nutritious food to our children. This program not only fills the bellies of the children in the community, but the souls of those that prepare, deliver, and serve lunches. It is amazing to witness joy-filled intergenerational relationships grow while preparing the lunches. The program is also growing young leaders and allowing youth to experience the joy of serving others. Please keep your eyes and ears open for opportunities to reach children in need. We look forward to serving with you again in 2023!

## North Scott Food Pantry 2022 Annual Report

The North Scott Food Pantry, located in the basement of Faith Lutheran Church, is open to assist families in need on Tuesday evenings, 5:30 – 7:00 PM and Friday mornings 9:30 – 11:00 AM. Highlights for 2022 include:

- A total of 531 visits were logged in 2022 which is 50% more than 2021 but still short of prepandemic use. In the fall of 2019, about 80 families came to the pantry each month. In 2022 the pantry served an average of 45 families each month with only 24 families coming in February and the high of 61 families in August. By May of 2022, the pantry returned to client choice for all clients regardless of vaccination status.
- The pantry is well stocked for 2023. The community has been very supportive with many groups, businesses and families donating food and/or money to the pantry. The NSFP continues to partner with River Bend Food Bank and MidWest Food Bank, Peoria. Weekly a volunteer picks up items from Panera. Food is also purchased from local retailers when it is not available at the food bank. All food donations and purchases are weighed and in 2022, 39,134 pounds were recorded.
- Notable donations: St. Ann's Knights of Columbus annual golf open raised \$18,000. Howard & Carole Harkins Charitable Trust donated \$10,000 and Fidelity Charitable Trust donated \$5000. Ed White School collected 493 boxes of cereal. The Lancer girls' basketball team hosted the "cart races" at North Scott Foods. The event donated 1490 pounds of food worth about \$2800. North Scoot Foods' customers purchased 49 care package grocery bags costing \$20 each. North Scott Chamber's Hometown Holiday raised \$1155 (plus food donations) and Eldridge Lions donated \$1000.
- Extra kid friendly food was given to families with school aged children over the summer.
- School supplies were collected in July. Each school in the district received a large box of supplies.
- A power point presentation was compiled to share information about the pantry to the community.
- Non-food items such as toilet paper, laundry soap and shampoo are available at the pantry. In 2022 we added paper towels, tissues, can openers and feminine hygiene products to the inventory.
- Clients received additional food the month prior to Easter and Thanksgiving. Clients received a 4# ham, cheese, buns and a bag of shelf stable food along with vouchers for eggs, milk and produce. 35 families received Easter food and 61 families received Thanksgiving food.

Christmas food boxes and angel tree gifts were given out December 16 & 17. A small group from the Eldridge Lions Club packed the food boxes in early December. On distribution days, a small group of volunteers added the perishables and loaded the food into the client's vehicles. 85 boxes of food were distributed to 79 families. Christmas gifts provided by St. Ann's and the Scott County Library's angel trees were distributed to about 90 children.

We have wonderful volunteers that staff the pantry, pick up and deliver items, stock shelves and put in many hours working on projects. Many volunteers use their gifts to make sure the food pantry functions efficiently. Friday hours are staffed by local churches in a 7-week rotation. Faith is scheduled for February 10 and March 31. If you would like to help, please contact Deanna Nielsen (285-6194). If you are interested in helping on Tuesday evenings, call the food pantry (285-8444) and leave a message.

Thank you to everyone that donated their time, food and/or money to the food pantry. A big thank you to Faith Lutheran for housing the pantry!
